AN ORDINANCE abating the tax heretofore levied for the year 20__ to pay debt service on _____ Bonds (Alternate Revenue Source), Series _____ of the _____ Park District, _____ County, Illinois

WHEREAS, the Board of Park Commissioners (the “Board”) of the _____ Park District, _____ County, Illinois (the “District”), by ordinance adopted on the _____ day of _____, _____ (the “Bond Ordinance”), did provide for the issue of \$_____ _____ Bonds (Alternate Revenue Source), Series _____ (the “Bonds”), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the District will have Pledged Revenues (as defined in the Bond Ordinance) available for the purpose of paying the debt service due on the Bonds during the next succeeding bond year; and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 20__ to pay such debt service on the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Ordained by the Board of Park Commissioners of the _____ Park District, _____ County, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 20__ in the Bond Ordinance is hereby abated in its entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerk of _____ County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 20__ in accordance with the provisions hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect upon its adoption.
